The vehicle was stopped for driving recklessly and failing to yield. I arrived and attempted to contact the passenger (later ID'd using his WAID as [REDACTED] 88). The male initially refused to roll down the window. S/[REDACTED] kept reaching into the center console and moving his hands between his legs towards the front of the car. Where S/[REDACTED] was reaching was not clearly visible through the window, the vehicle's dome light was not on. I reached for my service weapon and ordered the passenger to stop moving his hands, he complied. Myself and Ofc. Williams #7472 attempted to escort S/[REDACTED] out of the vehicle. S/[REDACTED] turned towards Ofc. Williams and threw his arms out to his side and balled up his fists. We escorted S/[REDACTED] to the hood of my patrol car. S/[REDACTED] eyes were watery and blood shot, he slurred his speech and repeated the same statements over and over. While speaking to him S/[REDACTED] stated, "You fucking pussies, that's why you cops are all getting blasted, you motherfuckers, wait until I bring my homeboys." S/[REDACTED] also challenged Ofc. Steiger #7503 to, "take off his fucking badge and I'll take you."

A computer check revealed S/[REDACTED] was under active supervision by DOC. No DOC was available citywide. An E-mail was sent to S/[REDACTED] supervising officer detailing S/[REDACTED] behavior.

The roads were wet and the weather was mixed precipitation, sleet and rain with near freezing temperatures. The vehicle made a southbound turn in front of us without slowing to a reasonable and safe speed for the turn. The vehicle travelled into the northbound traffic lane of Boylston Ave while traveling southbound at speeds in excess of 40 and 50 mph. The vehicle continued at a high rate of speed on Boylston Ave, swaying from side to side in the road, coming within a few feet of parked cars on the side of the road. It took us three blocks to catch up to the vehicle at approximately fifty miles per hour and the vehicle still gained distance on us travelled at a high rate of speed until it slowed for the stop sign at Boylston Ave and E Pine St. The vehicle did not stop for the stop sign and there were half a dozen pedestrians near the cross walk. After we initiated our overhead lights the vehicle continued slowly for an additional block and a half until it pulled to the side of the road.
